**Please read and understand this document before signing. If you have any questions, please ask us or consult an attorney.**

Boulder Rifle Club, Inc., its members, employees, agents, directors, officers, sponsors, advertisers, volunteers, contractors and subrogors (hereinafter BRC) have done everything reasonable to ensure that you have a safe and rewarding experience. We wish to inform our guests/members that using firearms, rifle and pistol ranges, participating in matches, or learning how to use firearms (hereinafter shooting) are not risk free and could cause loss or damage to equipment, injury, illness, or in extreme cases, permanent trauma, or death. We ask that you read this, sign it, and return it.

**EXPRESS ASSUMPTION OF THE RISK**

Any activity involving rifles, handguns, air guns, archery equipment, shotguns or other firearms runs the risk of an accident. Make sure you understand how the firearm will work, how it is to be loaded and unloaded, carried, transported and handled. Injuries can occur from using and/or transporting a firearm unsafely.

Discharging firearms, in addition to noise, can also produce smoke, fumes, and other airborne contaminants that you may find noxious, or that may be unhealthy. Bullets can ricochet and travel long distances; ammunition can malfunction injuring you and/or others around you. Always wear eye and hearing protection as a shooter or as a spectator. If pregnant, please consult your physician before entering a shooting range.

Most of the BRC ranges are in the open and subject to weather and other natural conditions, including the possibility of lightning strikes; footing can be slippery, uneven, wet and or muddy. Use caution when driving or walking on BRC property.

The possession and use of drugs and alcohol are forbidden on BRC property, and no one may enter the range or shoot when under the influence of alcohol or drugs.

You certify that you have reviewed this document with your family and that you have examined the BRC’s website and looked over the information, risks and any videos posted there. You certify that you and your family, including minor children, are fully capable of participating at a shooting range, and the programs offered by the BRC. Therefore, you assume full responsibility for yourself, your family, including minor children, for bodily injury, death, and loss of personal property and any expenses as a result.

The BRC reserves the right to refuse any person it judges to be incapable of meeting the requirements of participating in activities at the BRC, or any person who is in violation of its range rules.

You understand and agree that this is a voluntary activity, and you are doing so for recreational purposes and do so voluntarily. If a parent you agree to read and to explain to any minor in your family all posted signs and warnings, including instructions on use of equipment as well as the risks outlined in this agreement. You agree that you will obey all signs, and warnings posted and will obey instructions from staff.

If you do not want to sign this release, you understand you cannot use or shoot at any BRC facility, and you are free to go shooting elsewhere.

You acknowledge that you have received a copy of this document if you wanted one.

**I have read and understood this agreement. I am voluntarily signing this agreement. I understand that I am indemnifying the BRC, its members, employees, directors, officers and volunteers from any action at law that may arise from my use or presence on the premises. I also understand that pursuant to Colorado Revised Statutes § 13-22-107, this release is effective in preventing claims or litigation for injuries I or my child may receive.**
